## **Welcome and Approval of Minutes**

### **Line Extensions**

Jerry Bennett presented a line extension for William P. Moore-5555 W. 247<sup>th</sup> Street. The extension was estimated at 460 feet. Jim Bracken moved to approve the line extension. Gary Guetterman seconded the motion. Motion passed 8-0.

## **Old Business**

There was discussion on the possibilities of setting up zones for Board members. Carl Hartley reviewed the information he had researched. No other Districts in the state have established zones for Board members. The division of the District in three or four zones was discussed. Carl Hartley was going to continue to work on a proposal.

#### **Engineering**

Jerry Bennett reported the engineers are still waiting to hear from the state KDHE on approval of the Louisburg booster station design permit. The engineers are also working with Miami County to see what permits would be needed for the construction upgrade.

### <u>Legal</u>

Carl updated the Board on the Louisburg dispute. The final arguments have been submitted. Louisburg has asked for an extension. Their filings are due by the 30<sup>th</sup> of the month. The District will then have a chance to make an argument back if so needed. Then the judge will take it under consideration.

Carl also reported to the Board the status of the CUP appeal. There was discussion on what would happen if the appellate court approved the CUP.

#### **Treasurer's Report**

Alan Hire said there was no activity this month; the next CD matures in August.

#### **Manager's Report**

Jerry Bennett reported on the advisory committee meeting with Rural Water District No. 7, Johnson County, KS and Rural Water District No. 2. Rural Water District No. 7 will want more water to serve the intermodal. The ability to provide them additional water was discussed. They can also get water from Olathe. There was also discussion of joint tower with Spring Hill, Rural Water District No. 7 and Rural Water District No. 2.

Jerry Bennett said the same advisory meeting will have to be held with Spring Hill later this year.
