Welcome and Approval of Minutes

Chairman Jim Dycus called the meeting to order at 7:30 p.m.

Old Business

Chairman Dycus said Carl Hartley emailed information regarding sample lease agreements, term of agreement and fee for tower lease for the Board's review. It was the consensus of the Board to proceed with discussions and putting together specifics with Brolly Communications.

Chairman Dycus updated the Board on the Joint Advisory meeting with Water #7. Water #7 has several items they are working on before there will be any discussion on additional water demands. Water #7 thought it might be five to seven years for them to reach peak demand.

The Board discussed future demands, future contracts and agreements, the District's responsibilities to current patrons and wholesale customers. Water #7 said they would like to contract an additional 500,000 gallons. The District's current buffer is 750,000 gallons.

Legal

Carl Hartley stated Jerry Bennett was contacted by the Kansas Department of Transportation regarding a dip in K68 Highway and Rockville Road. The state resurfaced the road and now there is a dip in the road. The state wants the District to pay for the repairs. The line the District put in was eleven years ago. The sixteen inch line was a rock bore under the highway. It was installed nine foot deep with a twenty inch casing. Carl informed the Board the statute of limitations was ten years.


Treasurer's Report

Lana Kettler reported a twenty-four month general funds CD was opened at 1st Option Bank with a rate & APY of 0.83%. There are ongoing discussions with the bank of opening additional CDs for the same time frame and rate. The treasurer will make the decision when he gets back from vacation.

Manager's Report

Jerry Bennett reported the drought watch was over and the water restrictions have been lifted.

Jerry Bennett brought the Board up to date on the intake pump repairs. He presented the following costs projections and figures:

Jerry Bennett stated ABA Pump Supply would void the one year pump warranty if Alliance touched the pump. Alliance was contracted to pull the pump and inspect it. ABA showed up to watch Alliance take the pump apart. According to Alliance, a failed bearing on the pump seized and caused the motor to fail. That was the last communication with ABA Pump Supply. Jim Bracken moved to proceed with Alliance doing the above stated work for \$94,138.59 with a written warranty. Lyle Wobker seconded the motion. Motion passed 5-0.
