Welcome and Approval of Minutes

Chairman Jim Dycus called the meeting to order at 7:00 p.m.

Glenn Alpert moved to dispense with reading the minutes for the regular monthly meeting. Lyle Wobker seconded the motion. Vote: 8-0, motion passed.

Mike McClurg moved to approve the minutes as corrected (Spelling and Grammar). Brad Ryckert seconded the motion. Vote: 8-0, motion passed.

Alan Hire moved to pay the bills as presented excepting check number 11305 to Triangle Builders. Glenn Alpert seconded the motion. Vote: 8-0, motion passed. Jerry Bennett presented the final pay request from Triangle Builders for the Lab Upgrade in the amount of \$20,115.00. The project is 100% complete. Treasurer's Report

Alan Hire stated all three Certificates of Deposit mature in July.

Manager's Report

Jerry Bennett reported on the Fontana Interconnect. The District, City and USDA met. The contract has been approved. Rural Water District No. 2 is approved to proceed with the line extension to the connection point.

Jerry Bennett informed the Board of his meeting with Rural Water District No. 1, Mi Co, regarding potential substitute service agreements with one or two property owners near 311th & Plum Creek. There is also the ongoing discussion with a Miami 1 patron south of 319th & Bethel Church. The patron is still considering the option presented to him.

Jerry Bennett stated the District has contracted with Central Tank Coatings to repaint the Louisburg tank this fall. It will totally be repainted, inside and out.

There has been no news from the Stanton area residents and their need for water.

Jerry Bennett said the Home Owners Association meter would not require a change in the Bylaws. It could be treated as a wholesale meter. Staff and the HOA are working through the paper work.

There was a discussion the new construction in the Spring Hill area. Jerry Bennett said the areas were being served by Water One and Water District #7. There was additional discussion on Water #7 wanting more water and the need for an engineer to review and recommend future capital cost to larger wholesale customers as they need additional allocation.
