The regular meeting of the Board of Directors of Rural Water District No. 2, Miami County, Kansas was held on October 14, 2024, at the District Office located at 25290 Harmony Road, Paola, Kansas.

Chairman Wobker called the meeting to order at 6:00 p.m.

### Approval of Minutes and Invoices

Glenn Alpert moved to dispense with reading the minutes for the regular meeting held in September. Pete Peuser seconded the motion. Vote: 7-0, motion passed.

Mike McClurg moved to approve the minutes as written. Brad Ryckert seconded the motion. Vote: 7-0, motion passed.

Alan Hire moved to pay the invoices as presented except checks #18119 Midwest Engineering \$187,837.01, #18133 Crossland Heavy Contractors \$657,211.52, #18111 C&C Group \$316,265.00 and #18131 Anderson & Byrd, LLP \$4,888.25. Glenn Alpert seconded the motion. Vote: 7-0, motion passed.

Jerry Bennett reviewed the invoices: check #18131 Anderson & Byrd, LLP, is for Jo 7 contract legal services, check #18111 C&C Group is for the Phase 2 generator. Lana Ketter presented the invoices for #18119 Midwest Engineering, which contains two months of billing for the KDOT and plant projects. Jerry Bennett addressed check #18133 Crossland Heavy Contractors. The Crossland Heavy Contractor invoice is for electrical, trusses, and drains. Glenn Alpert moved to pay the invoices as presented.
