Call to Order: Chairman Wobker called the meeting to order at 6:00 p.m.

Approval of Minutes

K68 Hwy Project: Trenton Morris reviewed at the last meeting there was a motion to award the contract for the K68 Hwy project. Due to cost correction, Midwest Engineering suggested to rescind previous award and create a new motion with corrected cost awarding the contract for \$4,144,427.00 using 12in PVC pipe.

Pete Peuser moved to rescind the previous motion to accept the bid from NPL Construction Co on K68 Hwy using HDPE pipe \$3,267,033.00 on April 14, 2025. Charlie Sievert seconded the motion. Vote: 8-0, motion passed.
